The Board approved the October 11, 2023 regular meeting minutes on a motion made by Mr. Parker, seconded by Mr. Siarkowski, carried four (4) in favor, two (2) absent, and none (0) opposed.

October 24, 2023 MEETING MINUTES

The Board approved the October 24, 2023 special meeting minutes on a motion made by Mr. Siarkowski, seconded by Mr. Parker, carried four (4) in favor, two (2) absent, and none (0) opposed.

CORRESPONDENCE

PLANT OPERTIONS

Odor Complaint

Plant Manager Arnold reported a resident from Route 67 in Johnstown filed an odor complaint by email on October 28, 2023. Manager Arnold notified the resident that odors may be traveling offsite due to a failed pump. Manager Arnold reported the complaint to NYS DEC. The complaint was posted to the Odor Complaint Log on the GJJWTF website.

NYSERDA Incentive Payment

Plant Manager Arnold reported he filed an incentive payment request for the 6th year performance of Cogeneration Engine No. 3, under the Anaerobic Digester Gas-to-Electricity Program (PON 2828). Payment of \$83,771.35 was received for the measurement and verification period of July 3, 2021 to July 3, 2022. The 7th year performance payment is pending.

INDUSTRIAL COMPLIANCE

Permit Modification – FAGE USA Dairy

Laboratory Director Levendusky reported that FAGE USA Dairy submitted a request for revised allocation for annual average workday loadings in 2023 as follows:

- Decrease Flow from 918,133 gals/day to 566,490 gals/day,
- Decrease TSS from 4,031 lbs/day to 3,202 lbs/day,

- Decrease BOD from 13,385 lbs/day to 10,113 lbs/day,
- Decrease TKN from 751 lbs/day to 451 lbs/day.

On a motion made by Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board granted changes to FAGE USA Dairy Permit No. 233 for revised allocations for annual average workday loadings.

Sewer Bill Protest: 2 N Main Street, Gloversville

Plant Manager Arnold reviewed a request for sewer bill adjustment for excess water usage for property located at 2 N. Main Street in Gloversville. Manager Arnold conducted an inspection of the premises. On a motion made by Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board denied a credit since the excess water entered the sewer system and had to be treated.

Sewer Bill Protest: 10 East Blvd, Gloversville

Plant Manager Arnold reviewed a request for sewer bill adjustment for excess water usage for property located at 10 East Blvd. in Gloversville. On a motion made by Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board denied a credit since the period usage is within the normal range for this address.

BUGET/PURCHASE/AUDIT

2024 Health Insurance Options

Plant Manager Arnold reviewed employee healthcare plans and projected premiums for 2024. On a motion made Mr. Siarkowski, seconded by Mr. Parker, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board approved healthcare options as presented. Manager Arnold noted healthcare brokers Brown & Brown will meet with employees to discuss open enrollment on November 16, 2023.

Dental Insurance

Plant Manager Arnold reviewed employee dental plans and projected premiums for 2024. On a motion made Mr. Siarkowski, seconded by Mr. Parker, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board approved remaining with the current dental plan.

2024 General Fund/Capital Budget

Plant Manager Arnold distributed copies and reviewed the proposed 2024 General Fund Budget and projected threeyear Capital Plan. On a motion made Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board approved the 2024 O&M General Fund Budget as presented.

Resolution No. 2023-16

On a motion made Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed, the Board approved Resolution No. 2023-16. *Adoption of 2024 O&M General Fund Budget Totaling* \$5,623,265.00.

O&M purchase orders and disbursement sheets totaling \$233,478.90 were approved for payment on a motion made by Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed.

Capital disbursement sheets totaling \$150,000.00 were approved for payment on a motion made by Mr. Siarkowski, seconded by Mr. Schwartz, carried four (4) in favor, two (2) absent, and none (0) opposed.
